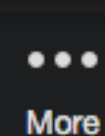
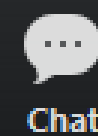
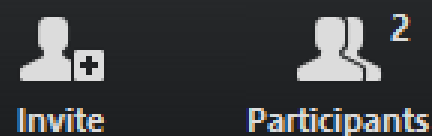
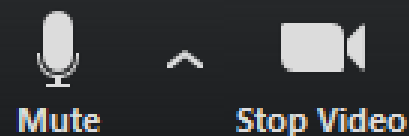
- All attendees – please mute yourself unless you are speaking!

If there is too much background noise, the moderator will mute your line automatically.

- See your control panel at the bottom of your screen. You can turn your audio and video on or off by clicking the **microphone** or **camera**.
- **Participants** shows a list of who is in the meeting. You can rename yourself or click the “Raise Hand” button if you want to ask a question.
- **Chat** opens up a shared window where you can type comments or questions to be read by the moderator.
- **Interpretation** allows you to attend in your language of choice.

HICP Membership Update

HICP Guiding Principles

(from our Vision
and Mission
document)

1. All participants agree to basic principles prioritizing equity, community resilience, and health in all programs and projects.
2. All participants agree to approach issues with an open mind, be willing to engage in dialogue, and commit to thinking boldly about solutions.
3. Participants will state views and ask genuine questions.
4. Participants will seek to avoid monologues and arguments; move to conversations where participants are curious and seek to understand various points of view.
5. Participants will explain reasoning and intent; share how we reach our conclusions so that others can understand our divergent reasoning.
6. Participants will attack the problem and not the person, organization, or institution.
7. Participants will define key terms so that we can attain a shared understanding.
8. Participants will share all relevant information.
9. Participants will always arrive prepared for the meeting.
10. During meetings, only one person speaks at a time; we will not engage in sidebar conversations.
11. Participants will work to develop a comprehensive, common set of information with which to solve problems and make decisions.
12. Participants will jointly design next steps.

Virtual Voting Process

Modified from in-

HICP Bylaws

- All voting items must be communicated in advance to Partnership members with sufficient time for review.
- The voting item will be introduced and discussed at a regular Partnership meeting.
- A vote may be cast by either the voting member or their alternate.
- The Partnership will take a temperature check (up to two rounds) to achieve agreement in order to move forward to a vote.
- Non-voting members will be excused from the meeting, and the voting members (per signed membership agreements) will vote on the item.
- Voting members may vote yes, no, or abstain.
- The vote will pass using a simple majority (50%+1) of the present eligible voting membership for the final vote.

Women's and Children's Hospital Demolition

(1240 North Mission Road – Corner of Zonal and Mission)



Project Description

- Demolition of +/- 390,000 sqft – Decommissioned 12-story WCH
- Demolition of 6 surrounded trailers
- Demolition of Cooling Tower/Air Compressor and WCH Storage
- Abatement of hazard materials
- Creation of surface parking lot until funding for future Restorative Village Psychiatric Hospital are secured.

Status and Next Steps

- Debris Removal is complete
- Demo Service Contract Award - for WCH Stuct. Demo targeted for September 2020
- Flyer to Community alerting them of the forth-coming demolition
- WCH Structural Demolition anticipated to start September 2020

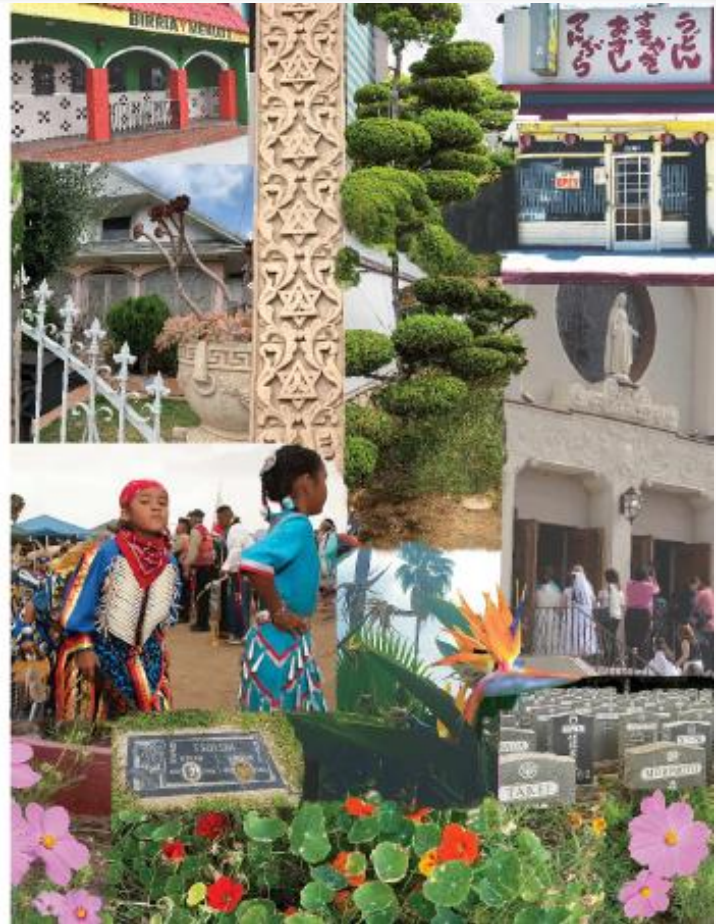

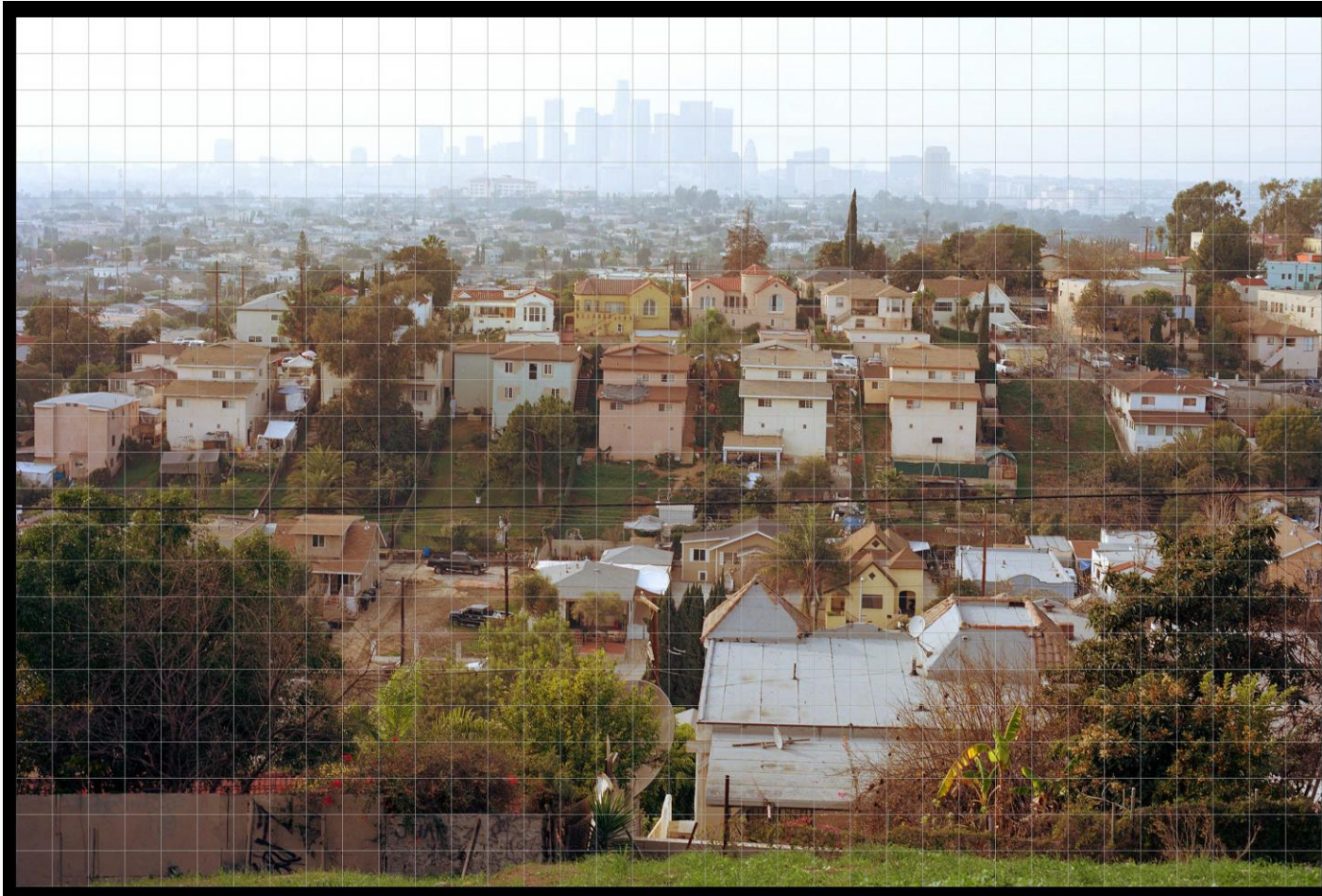

Schedule and Process

- **July 2020:** Announcement to HICP of up-coming Civic Art opportunity
- **August 2020:** Request for recommended artists to participate in Request for Qualifications (RFQ) – Deadline September 15, 2020
- **September 2020:** Release of RFQ on LA County website and email; and Request for help to distribute RFQ to artists – Deadline October 2020
- **Mid October 2020: Project Coordination Committee (PCC) #1:** Select Artists to Create Proposals
 - PCC includes:
 - User Group Representative: Jorge Orosco
 - (2) Voting Community Representatives
 - (1) HICP & (1) CCC Parent Advisory Group
 - Unlimited non-voting Advisors
 - Arts Professional: Star Montana (Artist & Educator)
 - Selected Artists work on proposals for six weeks
 - **Mid December 2020: PCC #2: Selects Successful Proposal for Commission**
 - Same Committee as PCC #1
 - **January 2021:** Successful Artist submits final design based on comments from PCC #2
 - Art Department shares final design with HICP
 - **February 2021:** Artwork fabrication begins
 - **May/June 2021:** Installation of artwork

Metro 710 North Mobility Improvements Projects (MIP)

- \$1.027 billion was allocated to San Gabriel Valley Cities, the City of LA, and the County of LA in 2018 and 2019
- Funding sources include local Measure R, state Regional Improvement Program (RIP), federal Congestion Mitigation and Air Quality (CMAQ), and federal Regional Surface Transportation Program (RSTP)
- Funding can be used for mobility improvements within local jurisdictions, primarily to improve north-south mobility

Metro 710 North Mobility Improvements Projects (MIP)

- \$300 million was allocated to the County of LA and City of LA
 - \$150 million for unincorporated East LA
 - \$150 million for City of LA neighborhoods including El Sereno, Northeast LA, etc.
- Most funding for LA County MIP is available beginning FY 2021-22
- LA County MIP includes Traffic Sync and Infrastructure projects

Next Steps

- LA County Public Works will lead a planning effort to conduct outreach throughout the entire East LA community
- SD1 will work with the RCV and GH teams to embark on a transportation improvements study/analysis for the LAC+USC campus

Valley Blvd Multi-Modal Transportation Improvements Project

- **Scope:** Feasibility study to look at transportation improvement concepts along Valley Blvd between Union Station and City of Alhambra boundary
- Improvements may include walking/biking paths, bus rapid transit, and rail realignments/modifications
- Funded through LA City MIP (\$34 million) and a portion of LA County MIP (\$30 million)

Valley Blvd Multi-Modal Transportation Improvements Project

Next Steps

- City of LA is procuring a consultant to conduct the feasibility study
- First phase of the study will involve community outreach
- City of LA will attend a future HICP meeting for update on LA City MIP

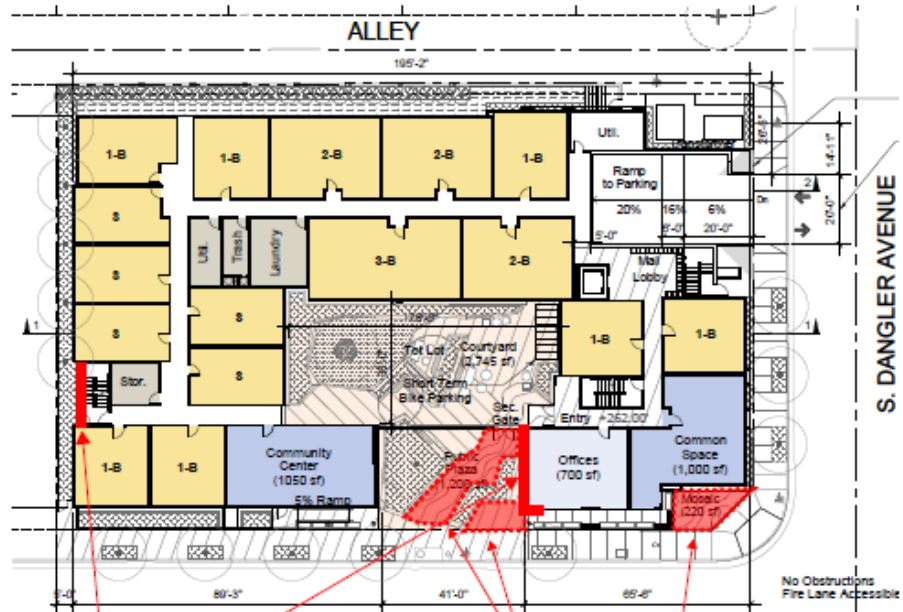
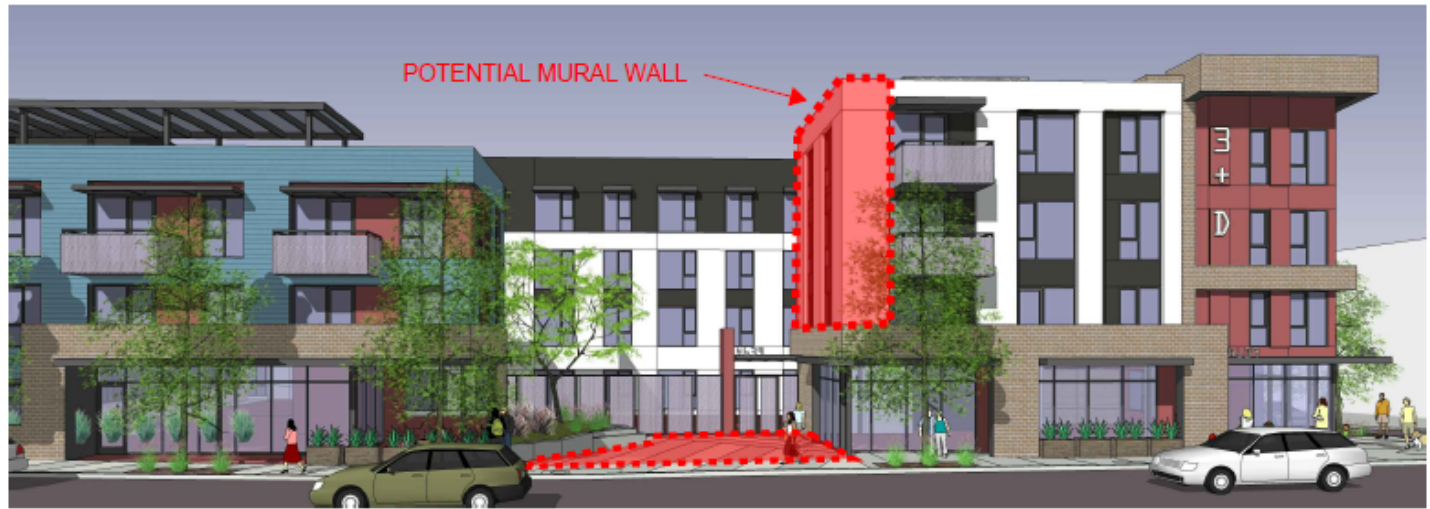
